Peter Rodriguez

Dean, Jesse H. Jones Graduate School of Business, Rice University

Peter Rodriguez has been dean of the Jesse H. Jones Graduate School of Business at Rice University since 2016. During that time, he has doubled MBA enrollment, grown the tenure-track faculty by more than 35%, introduced the first online graduate degree at Rice, launched the undergraduate business major, renovated McNair Hall, including a new public art project, and helped the Rice Business community survive Hurricane Harvey and grow stronger during COVID-19. His tenure as dean has also ushered in a new Office of Diversity, Equity and Inclusion, a relationship with The Consortium for Graduate Studies in Management and a rise in underrepresented minority students.

An economist and professor of strategic management, Peter also teaches MBA classes on leadership. He is presently serving a three-year term on The Federal Reserve Bank of Dallas, Houston Branch board of directors. Peter is also a board member for three nonprofit organizations: Good Reason Houston, Strake Jesuit College Preparatory, and Texas 2036.

Peter holds an M.A. and Ph.D. in economics from Princeton University and a B.S. in economics from Texas A&M University. He came to Rice from the University of Virginia's Darden School of Business where he was a professor, senior associate dean for MBA Programs and chief diversity officer. He also worked for several years as an associate in the Global Energy Group at JP Morgan Chase.

Doug started his corporate career as Director of Business Development for A123 Systems, a company founded on technology and patents Doug developed and filed during his graduate research at MIT. At A123 Systems, Doug's market focus was aviation, electric vehicles, and utility scale energy storage product lines. A123 went on to have a \$1.5B initial public offering in 2009.

Prior to this he served as a Naval Special Warfare Officer (SEAL) for nearly 10 years. During this time, he led an 18 SEAL unit deployed in flooded submersibles, launched from submarines and used by SEALs to complete clandestine underwater infrastructure demolitions. In Iraq, Doug was charged as Task Unit Commander to lead the 58-person Special Operations Wing during eleven days of intense urban warfare, in Najaf. For his actions in Iraq, Doug was awarded the Bronze Star with Valor.

Doug received his S.B. in Chemistry with distinction from the U.S. Naval Academy (1996). He also received an S.M. in Materials Science and Engineering from the Massachusetts Institute of Technology (2002) and his MBA from Harvard (2007). He is a member of the 2017 Class of Henry Crown Fellows within the Aspen Global Leadership Network at the Aspen Institute.
